# DISCIPLINARY ACTIONS AND DUE PROCESS

There are two types of discipline possible at Weston: Informal and Formal.

#### **INFORMAL DISCIPLINE**

Informal discipline takes place within the school. It may include:

Mandatory Parent Conferences Grades K – 8
 Loss of Recess Privileges Grades K – 5

• Silent Lunch Grades K– 8 (with teacher)

In School Suspension Grades K – 8
 Community Service Grades 3- 8

Our teachers have provided students with the established classroom rules which each student is required to follow. The students are always given ample opportunities to correct their misbehavior before additional consequences are imposed upon the student. When a teacher finds that the student continues his/her inappropriate behavior that student will be issued consequences based on the Student Code of Conduct.

#### IN SCHOOL SUSPENSION

It is the intent of the academy to provide every possible opportunity to keep students in the learning environment. The academy has adopted the I.S.S. policy in order to adhere to that intent. I.S.S. is a consequence issued that allows the student to come to school and complete all assigned classwork in a "restricted" area. Students are expected to comply with the I.S.S. rules at all times. Disregard to the rules will result in an additional consequence.

# **COMMUNITY SERVICE**

A program designed to provide an alternative consequence for those students in grades 3-8. Students will be assigned basic "housekeeping" duties under the supervision of our maintenance staff or ISS monitor.

#### FORMAL DISCIPLINE

Formal discipline takes place when the behavior of the student has gone beyond the point of being corrected by the informal discipline method and requires that the student be subjected to the consequences as stated in the Student Code of Conduct.

#### **DUE PROCESS RIGHTS**

All students suspended and/or expelled will be provided notice and an opportunity to be heard in accordance with a student's due process rights under the law. Nothing in this Policy shall diminish or be in derogation of the due process rights accorded to students who have been determined to be eligible for special education services under federal and State laws.

The administration of Weston Preparatory Academy reserves the right to adhere to the progressive discipline policy as stated in the Parent Student Handbook.
