

# PLAN FOR SAFE RETURN TO IN-PERSON INSTRUCTION AND CONTINUITY OF SERVICES

## **Introduction and Background**

In March 2021, President Biden signed the Federal American Rescue Plan (ARP) Act, Public Law 117-2, into law. The ARP Act provides an additional \$122 billion in Elementary and Secondary School Emergency Relief (ARP ESSER) to states and school districts to help safely reopen, sustain the safe operation of schools, and address the impacts of the COVID-19 pandemic on the nation's students. As with the previous ESSER funds available under the Coronavirus Aid, Relief and Economic Security (CARES) Act, and the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSA), the purpose of the additional funding is to support local educational agencies (LEAs) in preparing for and responding to the impacts of COVID-19 on educators, students, and families.

Section 2001(i)(1) of the ARP Act requires each LEA that receives ARP ESSER funds to develop and make publicly available on the LEA's website, no later than 30 days after receiving ARP ESSER funds, a plan for the safe return to in-person instruction and continuity of services for all schools (Safe Return Plan). A Safe Return Plan is required of all fund recipients, including those that have already returned to in-person instruction. Section 2001(i)(2) of the ARP Act further requires that the LEA seek public comment on the Safe Return Plan and take those comments into account in the finalization of the Safe Return Plan. Under the interim final requirements published in Volume 86, No. 76 of the Federal Register by the U.S. Department of Education (USDE), an LEA must periodically, but no less frequently than every six months through September 30, 2024, review and, as appropriate, revise its Safe Return Plan.

## **Plan for the 2024-25 School Year**

Weston Academy will offer in-person learning, five days per week according to the Board adopted 2024-2025 Academic Year Calendar.

1. **Universal and Correct Wearing of Masks:** The Weston Academy Board of Directors is committed to providing students, staff, and visitors with a safe and healthy environment. During times of elevated communicable disease community spread (pandemic or epidemic), the Academy will issue periodic guidance in alignment with public health officials and/or in accordance with government orders. Students, staff and parents may choose to wear face coverings due to personal preference or health conditions.
2. **Physical Distancing:** The Academy will follow all local and state regulations and policies with regards physical distancing.

3. **Handwashing and Respiratory etiquette** Handwashing will continue to be emphasized throughout the school day. Hand sanitizers will be placed throughout the buildings and students will be encouraged to sanitize their hands when entering and again when leaving a classroom. Cough and sneeze etiquette will be taught and reinforced.
4. **Cleaning and maintaining Health Facilities, including Improving Ventilation:** The Academy implemented several new cleaning procedures including use of electrostatic disinfectant sprayers frequent disinfection of high-touch surfaces and the installation of numerous hand sanitation stations. Ventilation will be continuously monitored to ensure necessary airflow.
5. **Contact Tracing in Combination with Isolation and Quarantine:** The Academy will follow all local and state regulations and policies with regards to isolation and quarantine and make necessary adjustments through the year when possible/necessary.
6. **Diagnostic and Screening Testing:** Families are expected to assess their student(s) health on a daily basis prior to attending school. If students/staff exhibit any COVID-19 related symptoms, particularly the loss of taste and/or smell, a temperature of over 100 degrees, and/or any shortness of breath or difficulty breathing, they should stay home. At any time, the Academy may take the temperature of students or employees upon arrival to school or at any time during the school day.
7. **Efforts to Provide Vaccinations to Educators, other staff and eligible Students:** Vaccine clinics will be publicized through Academy communication channels.
8. **Appropriate Accommodations for Children with Disabilities with Respect to the Health and Safety Policies:** The Academy will continue to provide health and safety accommodations in accordance with students' Individualized Educational Plans.

## **Ensuring Continuity of Services**

Weston Academy is committed to the highest academic and developmental outcomes for each student. As such, the Academy will ensure continuity of services, including but not limited to services to address students' academic needs and students' and staff's social, emotional, mental health, and other needs, including student health and food services.

### **Academic Services, Social-Emotional, Mental Health:**

- Academy has returned to in-person learning, five days per week.
- Virtual Learning: Weston Academy will have a virtual learning option for families in the event of a school or community COVID outbreak or on an individual basis as determined by the school leader.
- Social emotional screening and counseling support are available.

### **Health:**

- Students in the quarantine room will wear a mask, unless otherwise indicated.
- Academy staff will wear appropriate PPE.

### **Food**

- All students will have access to free breakfasts and lunches during the 2024-25 school year.
